## 2025 Outstanding Civic Service Award Guidelines

- 1. Nominations will be accepted until 5pm, February 28, 2025
- 2. Nominations will be accepted from civic clubs, non-profit organizations, schools and churches.
- 3. Nominations from previous years are not kept, names must be resubmitted.
- 4. All information and nominations become property of the chamber.
- 5. The Greater Iberia Chamber of Commerce Board of Directors shall select one recipient to receive the Outstanding Civic Service: Award for the nominees.
- 6. The quality of civic work the nominee performed is the deciding factor, not the quantity or number of submissions the chamber receives for the nominee.
- 7. Accomplishments must be outside that of the nominee's regular job or position.
- 8. Civic accomplishments considered are actions performed voluntarily and without pay. Local, state and national accomplishments will be recognized.

- 9. Nominee must be a resident of Iberia Parish.
- 10. The nomination must be submitted on letter size paper (8 ½ X 11), in the form of a typed narrative (one sided only, double spaced), and please not more than four pages.

- b. The nomination letter must be signed by an executive committee member or officer of the organization writing the nomination.
- c. The nominee must be identified by name in the narrative.
- d. specific dates may be used in the narrative
